- 6 Real Journeys supports the relief sought insofar as it is consistent with the relief set out in the Real Journeys' appeal, and in particular considers:
  - (a) The relief will better achieve the higher order provisions of the PDP; the Otago Regional Policy Statement, and Part 2 of the Act.
- 7 Real Journeys agrees to participate in mediation or other alternative dispute resolution of the proceedings.
