Confirmation of Minutes

1. Te Kararo Queenstown Gardens Conifer Succession Plan

The purpose of this report was for the Community & Services Committee (the Committee) to consider approving Te Kararo Queenstown Gardens Conifer Succession Plan (the Plan).

Briana Pringle, Lee Rowley, Stef White and Dave Winterburn presented the item and proposed an amendment to the Plan, which was incorporated into an updated resolution upon which the Committee informally agreed (and which is incorporated in the substantive motion specified below).

The proposed amendment to the Plan was displayed on the screen and officers explained why these amendments were being proposed. The amendments provided clarification and corrected some names of organisations cited in the Plan.

Officers responded to questions on how Council would respond if there were problems with implementation of the Plan, whether all stakeholders were consulted when it came to the amendments proposed by officers at the meeting, specification of specific groups in that amendment given that the interested parties may change in the future, and whether there have been any discussions with the Queenstown Chamber regarding future funding opportunities.

Councillors spoke in support of the Plan and thanked officers for their work. There was discussion over the submissions that had been received on the Plan, which had revealed a range of distinct views (both in support and in opposition).

It was moved (Councillor Wong, Councillor Tucker):

That the Community & Services Committee:

- **2. Adopt** the Te Kararo Queenstown Gardens Conifer Succession Plan with the following changes:

i. On page 15 (second to last paragraph) – Replace

"Planting locations will accommodate existing infrastructure, such as the Ice Risk and Field Team buildings, ensuring new plantings do not obstruct access, interfere with operations, or hinder maintenance activities like exterior repairs."

With

"In areas with existing infrastructure, planting locations will be carefully planned to integrate with facilities such as the Ice Arena and QLDC Parks Buildings. These areas will feature mixed woodland with open, spacious plantings to ensure unobstructed access, preserve window views, support operational requirements, and avoid interference with maintenance or other infrastructure."

ii. On page 19 - add the following new 'Expected outcomes':

"7.1.1 Community and Stakeholder Engagement, and Memorandum of Understanding (MOU)

The Te Kararo Queenstown Gardens Succession Plan will foster a deep sense of community ownership and stewardship by actively involving key stakeholders, including the Friends of Wakatipu Gardens (FOG), Whakatipu Wilding Control Group (WCG), Queenstown Bowling Club, Tennis Club, Ice Arena, and future stakeholders. Stakeholders will be kept informed as the tree succession plan and operations progress, ensuring alignment with community goals and operational needs.

A Memorandum of Understanding (MOU) will be established to document the core principles of the Plan, promoting ongoing engagement, transparency, and collaboration throughout the project. The MOU will outline how stakeholders will support the Plan's operational components, including the formation of a management group to oversee implementation, make decisions on key milestones and hold points, and guide the principles shaping the Plan's execution. This includes conducting seasonal planting walkover assessments to

evaluate the progress and establishment of new plantings and to plan subsequent stages of the project."

3. Direct staff to enter a Memorandum of Understanding (MOU) with the Friends of the Gardens (FOG) and the Whakatipu Control Group (WCG) and any future Queenstown Gardens stakeholders to record overarching principles of Te Kararo Queenstown Gardens conifer succession plan.

Motion was <u>carried</u> unanimously.

2. Chair's Report
