# **Grand Prix Hydroplane Racing**

To ensure the safety of all lake users, Public Notice is hereby given that pursuant to the Queenstown Lakes District Navigation and Safety Bylaw 2018, Bylaw Clauses 31, 43 and 51 have been invoked to establish a Reserved Area and Speed uplift within Glendhu Bay to allow for the running of Grand Prix Hydroplane Racing.

This Reserved Area and Uplift will be in place on Saturday 12 and 13 November 2022 and applies to both private and commercial users.

From 8.00am on Saturday 12 and 13 November 2022, in the interests of public safety, the Glendhu Bay Exclusion Zone will be in force as indicated by Race Officials Vessels supporting a Red Flag. No unauthorised vessels are to enter the exclusion zone or utilise the Rotary Park launch facility until all clear is given by race officials.

All vessels wishing to view the racing from the water must remain clear of the area to minimise the effect of wake on Race boats and additionally comply with all instructions from Race officials or the Waterways team on site.

All boaties are reminded, that while on the water, they must comply at all times with the Maritime Law and the QLDC Navigational Safety Bylaw 2018. These laws incorporate rules around speed and visibility at night, but also that navigational lights on your vessel comply and are operational. Waterways staff will be on hand to enforce the Maritime Law and Bylaw on the night and may issue infringements if boaties fail to comply with these rules.

What is proposed

Consent is sought to establish a  $1000m^2$  residential building platform and to undertake associated earthworks and landscaping.

The proposed platform will be located in the south eastern corner of the site and will be accessed from a partly formed legal road along the southern boundary. Design controls are proposed relating to the form and bulk of future buildings, and to limit the type of cladding materials and exterior colours that can be used.

It is proposed to raise the finished floor level under future residential buildings by at least 0.5m above existing ground level, as recommended by the applicant's engineer, to mitigate any potential risk associated with shallow surface water flooding from Precipice Creek in extreme rainfall events.
