Ryby Island Swim Event

Public Notice is hereby given that pursuant to the Queenstown Lakes District Navigation Safety Bylaw 2025, Bylaw Clause 45.1 has been invoked to temporarily establish a reserved area within Roys, to allow for the running of the Ruby Island Swim event and to ensure the safety of all Roys Bay users. This reserved area will be in place on 24 January 2026 and applies to both private and commercial vessels & watercraft.

LOCATION/TIME:

From 6.00am to 12.00pm on 24 January 2026, in the interests of public safety, a Waterfall Creek/Ruby Island Exclusion Zone will be in force.

The exclusion zone extends 100m each side of the Waterfall Creek launch ramp and extends out to encompass an area 100m from all sides of Ruby Island.

NO unauthorised vessels are to enter the exclusion zone until the exclusion period has ended.

All vessels are reminded that while on the water, they must always comply with the Maritime Transport Act and the QLDC Navigation Safety Bylaw 2025. Harbourmaster staff may be on hand to monitor compliance with the Maritime Law and Bylaw on the day and may issue infringements if vessels fail to comply with these rules.
