

## VARIATION TO QUEENSTOWN LAKES PROPOSED DISTRICT PLAN Inclusionary Housing

Queenstown Lakes District Council has prepared proposed changes to the Queenstown Lakes Proposed District Plan (PDP) under Schedule 1 of the Resource Management Act 1991 (RMA). This proposal seeks to amend the PDP by including a requirement for a financial contribution from residential subdivision and residential development in specified PDP zones. The financial contribution would be used to fund retained affordable housing that would be developed by the Queenstown Lakes Community Housing Trust or another registered Community Housing Provider approved by the Council. The housing would assist low to moderate income residents into affordable housing. Developments that have already paid a financial contribution to affordable housing via an existing stakeholder deed would be exempt from the proposal.

The variation would amend the PDP by inserting a new Objective and Policies into PDP Chapter 3: Strategic Directions, and by adding proposed Chapter 40: Inclusionary Housing to Part 5 of the PDP.

Any written submissions that do not use the online form must be made using Form 5, as prescribed by the Resource Management (Forms, Fees, and Procedure) Regulations 2003. All submissions must state whether or not you wish to be heard in support of your submission at a hearing. The submission form is

available from the locations listed above, as well as the Ministry for the Environment and New Zealand Legislation websites.

**The closing date for submissions is Thursday 24 November 2022.**

### **What happens next?**

After submissions close:

- A summary of decisions requested by submitters will be prepared and publicly notified.
- People who represent a relevant aspect of the public interest or have an interest greater than the general public may make a further submission, in the prescribed form within 10 working days of notification of the summary of decisions sought, supporting or opposing submissions already made;
- A copy of the further submission must also be served on the Council and the person who made the original submission to which the further submission relates;
- Submitters may speak in support of their submission(s) at a hearing if they have indicated in their submission that they wish to be heard;
- Following the hearing, the Council will give public notice of its decisions and matters raised in submissions, including its reasons for accepting or rejecting submissions;
- Every submitter then has the right to appeal the Council's decisions on the proposal to the Environment Court.
