Whakatipu Legend 2024

To ensure the safety of all lake users, public notice is hereby given that pursuant to the Queenstown Lakes District Navigation Safety Bylaw 2018, bylaw clause 31 has been invoked to temporarily authorise a reserved area for a special event. The Whakatipu Legend 2024 event will be held in Queenstown Bay and Frankton Arm on **Sunday 24** March 2024.

The reserved areas apply to both private and commercial users.

Sunday 24 March

Queenstown Bay, Lake Whakatipu

Exemption: **Temporary Reserved Area**

Time/ Location: 07:00am to 11:30am, covering an area from Frankton Arm, approximately opposite the Rees Hotel, following along the shore front, around Queenstown Gardens and finishing in Queenstown Bay. The course will be marked by tall visible buoys and smaller guide buoys. All water users are to remain at least 200m back from the course.

As per the dates and times stipulated above, in the interests of public safety, the Queenstown Bay and Frankton arm reserved area will be in force. No unauthorised vessels are to enter the reserved area until all clear is given by officials. A map of the reserved area can be found on the QLDC Facebook page and is available on request.

All vessels wishing to view the event from the water must remain clear of the area to minimise the effect of wake and comply with all instructions from officials or the waterways team on site.

All boaties are reminded that, while on the water, they must comply at all times with the Maritime Transport Act 1994 and the QLDC Navigation Safety Bylaw 2018. Maps of the reserved area and contact information is available on request and will be sign posted on location.
