CONTEXT | HOROPAKI

- 1 Arataki is NZTA's 10-year view of what they consider to be required to deliver on the government's current priorities and long-term objectives for the land transport system.
- 2 Arataki looks across New Zealand with 14 regional summaries, 3 pan-regional summaries and 1 national summary. These summaries are framed by:
 - Five step changes where there is a need for change
 - Six key drivers trends that influence choices
 - Six levers or interventions tools to deliver priorities and outcomes.
- 3 Submissions on the plan were due to the NZTA prior to the first revision due to take place in April. Receipt of the submission and inclusion in the process was confirmed via email on Monday 30 March.
- 4 A further version of Arataki is planned to be released in August 2020 and QLDC anticipates that there will be opportunity for further comment at this stage.
- 5 Due to the timing of the submission response period between February and March there was insufficient time to seek Committee feedback prior to the submission due date. This submission was approved and submitted by the Chief Executive.

ANALYSIS AND ADVICE | TATĀRITANGA ME NGĀ TOHUTOHU

- 6 Officers prepared the submission to ensure that Queenstown Lakes District's unique circumstances and environment as a traditionally high growth area are properly considered throughout the development of Arataki.
- 7 QLDC supports the intent of this 10-year plan and the move towards integrated planning approaches supporting five key changes in development. With Queenstown Lakes District facing particular challenges a regional view is welcomed and Arataki's step changes mirror many of QLDC's priorities such as place-based planning and climate action. Officers highlighted in the submission QLDC's desire to work in partnership with NZTA to best serve the Queenstown Lakes District community through consistent and effective regulatory functions, and acting as management and financial partner through transport and infrastructure programmes.
- 8 The key points made in the submission are:
 - **Future Planning:** QLDC welcomes the intent by the NZTA, to improve the urban form by integrating transport systems into planning processes and land-use. The move away from the reliance on private vehicles is also welcomed.
 - **Emission Reduction:** Supported by improving urban form to allow connected landscapes, and transforming urban mobility allowing the move away from private vehicle usage, emission reduction is a key area of climate change mitigation.

- **Strategic Integration:** Within planning processes using Arataki, a hierarchy of national policies and strategies to which investment plans can align to appropriately should be identified.
- Spatial Planning: The Queenstown Lakes Spatial Plan will be fundamental to the
 delivery the five step changes of the Arataki providing more certainty about how
 an area will grow and the long term strategic direction for the Queenstown Lakes
 area.
- **Place-based Summaries:** QLDC officers have suggested inclusions and/or amendments to the national, pan-regional and regional summaries.
- 9 Option 1: to retrospectively agree the contents of the attached submission.

Advantages: The submission will remain in the NZTA revision process and QLDC will have partaken in the Arataki review process.

Disadvantages: There are no clear disadvantages to this option.

10 Option 2: to request the withdrawal of the attached submission from the NZTA revision process.

Advantages: The submission will be withdrawn from the NZTA revision process and any inaccurate representations of QLDC's position will not be considered.

Disadvantages: QLDC will not participate in the first update of the Arataki process, as it will not have submitted on this occasion

- 11 This report recommends **Option 1** if the submission is broadly reflective of the Council's position.
- 12 Option 2 is only recommended in the event that the direction taken by the submission is incorrect and fails to capture the position of the Council at all.

- 13 This matter is of low significance, as determined by reference to the Council's Significance and Engagement Policy because proposed changes to the Arataki is not within the direct control of QLDC. However, this proposed 10-year plan deals with a matter of interest to a range of individuals, organisations, groups and sectors in the community.
- 14 The persons who are affected by or interested in this matter are residents/ratepayers of the Queenstown Lakes district community.
