It will be an offence under the above regulations for any person otherwise than under authority of an authorised permit to use the roads for ordinary vehicular traffic during the period of closure.

## Variation to Queenstown Lakes Proposed District Plan

### NOTIFICATION OF THE UPPER CLUTHA LANDSCAPE SCHEDULES VARIATION

Queenstown Lakes District Council has prepared the following Variation to the Queenstown Lakes Proposed District Plan (PDP) under Schedule 1 of the Resource Management Act 1991 (RMA).

This Variation proposes to amend Strategic Policy 3.3.36 of Chapter 3 – Strategic Directions of the PDP, introduce additional landscape areas into schedules 21.22 and 21.23, and amend the pre-ambles for Schedule 21.23 of Chapter 21 – Rural Zone. The Variation does not change the existing rule framework for subdivision and development within the Rural Zone.

The Variation was originally notified on 18 July 2024 but was withdrawn to allow the Council to correct minor errors with the mapping of the Mata Au Clutha River Outstanding Natural Feature. This correction, as well as feedback received through the Clause 34 process, resulted in several changes to the Rural Character Landscape areas (mapping and descriptions) that form part of the Variation. Queenstown Lakes District ratepayers (living in the Upper Clutha) will receive a copy of this notice by mail or email. Any written submissions that do not use the online form must be made using Form 5, as prescribed by the Resource Management (Forms, Fees, and Procedure) Regulations 2003. All submissions must state whether or not you wish to be heard in support of your submission at a hearing. The submission form (Form 5) is available from the locations listed above, as well as the Ministry for the Environment and New Zealand Legislation websites.

**The closing date for submissions is Friday 13 December 2024.**

### What happens next?

After submissions close:

- A summary of decisions requested by submitters will be prepared and publicly notified.
- People who represent a relevant aspect of the public interest or have an interest greater than the general public may make a further submission, in the prescribed form within 10 working days of notification of the summary of decisions sought, either supporting or opposing submissions already made;
- A copy of the further submission must also be served on the Council and the person who made the original submission to which the further submission relates;
- Submitters may speak in support of their submission(s) at a hearing if they have indicated in their submission that they wish to be heard;
- Following the hearing, the Council will give public notice of its decisions and matters raised in submissions, including its reasons for accepting or rejecting submissions;
- Every submitter then has the right to appeal the Council's decisions on the proposal to the Environment Court.
