Title | Taitara Submission on the Climate Change Commission's First Package of Advice

PURPOSE OF THE REPORT | TE TAKE MŌ TE PŪRONGO

The purpose of this report is to present the submission to the Climate Change Commission, in respect of its first package of advice to government. This report seeks retrospective approval of the submission's content. The submission was made to the Climate Change Commission on 26 March 2021.

CONTEXT | HOROPAKI

- 1 The Climate Change Commission, He Pou a Rangi (the Commission) is an independent body that provides impartial, evidence-based advice to the government, holding it to account on climate action. It provides advice on reducing emissions, adapting to the impacts of climate change and the monitoring and review of progress towards the government's emissions reductions and adaptation goals.
- 2 The Commission was established through legislation, when the Climate Change Response (Zero Carbon) Amendment Act 2019 came into force on 14 November 2019. Whilst the government is not bound to follow the Commission's advice, it is bound to follow proper process in its consideration. The government must respond to the advice and explain the reason for any departures.
- 3 The Commission's first task has been to provide advice on:
 - The level of the first three five-yearly emissions budgets that will put Aotearoa on track to meeting its domestic 2030 and 2050 emissions targets
 - The direction of policy that should be in included in the government's first emissions reduction plan.
- 4 This submission has been developed through a highly-collaborative process, working in partnership with the Climate Reference Group. The Climate Reference Group has provided extensive support throughout the process, providing expert advice across a broad range of topics.
- 5 The Commission's advice addresses the first three emissions budgets, provides policy direction for the government's first emissions reduction plan, offers a review of Aotearoa's first nationally determined contribution and advises on the eventual reductions needed in biogenic methane emissions.
- 6 Submissions on the Bill were due to the Commission by 26 March 2021.
- 7 Due to the timing of the submission response period there was insufficient time to seek Council approval prior to the submission due date, however Councillor feedback was sought through circulation of draft versions of the submission. This submission was temporarily approved and submitted by the Chief Executive and the Mayor.

ANALYSIS AND ADVICE | TATĀRITANGA ME NGĀ TOHUTOHU

- 8 Broadly speaking, QLDC is highly supportive of the direction being taken by the Climate Change Commission (CCC) and looks forward to an ongoing dialogue that will shape and define a just transition to a decarbonised economy.
- 9 QLDC strongly supports the advice to pursue the 1.5°C targets and to limit offshore mitigation. The recommended breakdown of the emissions budget is also considered appropriate.

- 10 QLDC supports the five emissions Budget Recommendations within the advice.
- 11 The need for an equitable, inclusive and well-planned climate transition is fully supported. This needs to be viewed with an holistic approach to wellbeing and a true focus on social equity.
- 12 QLDC fully supports the approach of 'locking in net zero' and the focus placed upon decarbonising sources of long-lived gas emissions.
- 13 The Commission requested local government bodies to specifically address potential barriers to change. As such, the submission provides a list of 20 barriers identified by QLDC. Additionally, QLDC has posed a set of 41 recommendations for the Commission's consideration.
- 14 QLDC has identified three key challenges that will need to be addressed in the district in light of the advice provided by the CCC. These are addressed in detail in part B of the submission.
 - Spatial Planning effective spatial planning and improved urban form will be essential for emissions reduction in the district.
 - Electrification significant energy network challenges will need to be overcome to decarbonise extensively.
 - Tourism the role of the visitor economy and tourism policy in reducing emissions is absent from the advice.
- 15 QLDC further notes that some of the key policy areas are unevenly addressed, with some areas explored in significant detail, whilst others (notably agriculture, waste and urban form) appearing light in evidence and detail. These policy areas are explored in detail in Part C of the submission.
- 16 <u>Option 1:</u> to retrospectively agree the contents of the attached submission.

Advantages:

17 The submission will remain in the Commission's process and QLDC will have partaken in the submissions process.

Disadvantages:

- 18 There are no clear disadvantages to this option.
- 19 Option 2: to request the withdrawal of the submission from the Commission's process.

Advantages:

20 The submission will be withdrawn from the Commission's process and any inaccurate representations of QLDC's position will not be considered.

Disadvantages:

- 21 No aspect of QLDC's position will be represented in the process.
- 22 This report recommends **Option 1** for addressing the matter because Councillors have had opportunity to view and comment on the attached submission prior to its inclusion in the process and therefore should be reflective of the Council's position.

25 There are two iwi representatives on the Climate Reference Group who have provided input into the drafting of the attached submission.

26 RISK AND MITIGATIONS | NGĀ RARU TŪPONO ME NGĀ WHAKAMAURUTANGA

- 27 This matter relates to the Strategic/Political/Reputation. It is associated with RISK00038 within the QLDC Risk Register. This risk has been assessed as having a moderate inherent risk rating.
- 28 The approval of the recommended option will support the Council by allowing us to implement additional controls for this risk. This shall be achieved by monitoring future changes in legislation based on the advice to government, in particular addressing those issues that directly affect QLDC and the Queenstown Lakes District community.
