# Notice of Intention to Revoke Recreation Reserve – Corner of Eleventh Avenue and Jones Avenue, Queenstown

#### PURSUANT TO SECTION 24 OF THE RESERVES ACT 1977

The land described in Schedule A of this Notice (the Land) is vested in the Queenstown Lakes District Council under the Reserves Act 1977 as recreation reserve.

The adjoining property developer has encroached upon a portion of the reserve and wishes to remedy the encroachment through acquisition. The Council is considering the reserve revocations and subsequent disposal of the Land, pursuant to Section 24 of the Reserves Act 1977 as the Land is no longer needed for reserve purposes because:

- a. The Subject Land is not being actively used for reserve purposes;
- b. The Subject Land is only a small portion of the reserve situated at this site and the wider Queenstown area;
- c. The Subject Land has little value as recreation reserve:
- d. The Subject Land is currently being utilised by Queenstown Commercial Limited for the Kawarau Park Shopping Centre.

Pursuant to Section 24 of the Reserves Act 1977 the Council has an obligation to publicly notify its intention to revoke the reserve classification by way of this Notice.
