- 1 The Hansen Family Partnership (**HFP**) wishes to be a party pursuant to section 274 of the RMA to the following proceedings:

*FII Holdings Limited v Queenstown Lakes District Council* (**ENV-2018-CHC-000084**) being an appeal against decisions of Queenstown Lakes District Council on the proposed Queenstown Lakes District Plan (**PDP**).

- 2 HFP is a person who made a submission about the subject matter of the proceedings.
- 3 HFP is not a trade competitor for the purposes of section 308C or 308CA of the RMA.
- 4 HFP is interested in all of the proceedings.
- 5 Without derogating from the generality of the above, HFP is interested in the following particular issues:
  - (a) The relief sought to rezone the FII land and adjacent land on SH6 Frankton ladies Mile Highway to Mixed Business Use Zone (MBU Zone), which includes the HFP land as outlined in its original submissions.
  - (b) Consequential amendments to the provisions of the above zone chapters to provide a site-specific regime for the Site and the Frankton North land, including by way of structure plan and associated subdivision rules.
  - (c) Consequential amendments to any strategic and higher order provisions of the PDP so as to support and give effect to the ultimate Frankton North zoning.
- 6 HFP supports the relief sought because the relief better achieves:
  - (a) The higher order provisions of the PDP, proposed and operative Regional Policy Statements;
  - (b) Section 32 of the Act;
  - (c) Part 2 of the Act
- 7 HFP agrees to participate in mediation or other alternative dispute resolution of the proceedings.
