Many people have been taught in it and been creative in it. 2. More than 40 schools are known to have existed in the Whakatipu. Now there are nine schools, none in old buildings. The building in question is a surviving part of the history of schooling in the district. If it is relocated to the Frankton site, the Historical Society offers to assist the Queenstown Art Society to display in it information about the history of the building and of education in the district. 3.Design and construction: The design is a distinctive mid-20th-century design for a school. It is a very sound example, being well-constructed and, as a QLDC asset, well-maintained. For these reasons, we support the removal of the building from the Council's schedule of assets.	No
