Henry v Queenstown Lakes District Council (ENV-2019-CHC-047) (**Henry Appeal**) being an appeal against decisions of Queenstown Lakes District Council on Stage 2 of the Queenstown Lakes Proposed District Plan (**PDP**).

- 2 Mark Tylden is a person who made a submission about the subject matter of the proceedings.
- 3 Mark Tylden is a person who has an interest in the proceedings that is greater than the interest that the general public has, in particular:

 - (c) The rezoning of part of the Ladies Mile to WBLP has the potential to affect the development of the entire Ladies Mile area, and as such the outcomes of the relief sought in the Henry Appeal may affect Mark Tylden's land interests.
- 4 Mark Tylden is not a trade competitor for the purposes of section 308C or 308CA of the RMA.
- 5 Mark Tylden is interested in all of the proceedings.
- 6 Without derogating from the generality of the above, Mark Tylden is interested in the following particular issues:
