- 1 Transpower New Zealand Limited ('**Transpower**') seeks to be excused from the upcoming Topic 20 mediation scheduled for 11 December 2019 to 13 December 2019.
- 2 Counsel received a notice of mediation dated 20 November 2019 which directs mediation for Topic 20.
