- We act for Remarkables Station Limited, and Dickson Stewart Jardine, Jillian Frances Jardine, Dickson Stewart Jardine and HGW Trustees Limited, Jillian Frances Jardine and HGW Trustees Limited (Jardine Family Land Partnership) (Remarkables Station Limited & Others) in relation to the appeals on Stage 1 of the Proposed Queenstown Lakes District Plan (Proposed Plan).
- In accordance with the Queenstown Lakes District Council Letter dated 12
   October 2018, Remarkables Station Limited & Others agree to amend part
   of its appeal relating to Jacks Point Topic: Chapter 41.
