- [1] This is a further submission from Park Ridge Limited in response to certain submissions made on the Te Pūtahi Ladies Mile Variation to the Proposed District Plan ('Variation').
- [2] Details of submissions and whether they are supported or opposed along with the reasons for opposition is contained in <u>Schedule 1</u> below.
- [3] Park Ridge Limited further submits that the land is not suitable for development, as the roading and related infrastructure will not support the scale and intensity of development proposed in the Variation and the area proposed is not suitable for the form and scale of development.
- [4] Park Ridge Limited further submits that certain submissions are not ON the Variation and there is no jurisdiction to include land in the Variation and for it to be rezoned.
