1. Update on Queenstown Lakes Spatial Plan Monitoring Report

The purpose of this report was to provide an update on the August 2025 Grow Well Whaiora Spatial Plan Monitoring Report.

Catriona Lamont (Spatial Plan Project Manager) and Anita Vanstone (Strategic Growth Manager) presented the report.

Ms Lamont and Ms Vanstone responded to questions about the 'Red' status of Mode Shift and Travel Demand Management initiatives, the challenges with progressing this initiative, and how critical mode shift is to achieving other aspects of the plan. They agreed it was a critical component and that current challenges were mostly due to limited resourcing. Further, that working with partnership agencies would remain important to make progress. It was discussed whether potential funding for crucial infrastructure could come from a regional deal negotiation.

Members commented on the importance of the Mode Shift and Travel Demand Management initiatives. Ms Lamont and Ms Vanstone noted that feedback from members would be taken to future discussions with the partnership agencies involved in the plan.

Ms Vanstone also provided an update regarding the short-term vs long-term letting analysis, noting that research results would be reported back to Council once finalised.

2. Update on Progress on the Proposed District Plan and Other Key Projects

The purpose of this report was to update the Planning & Strategy Committee on key projects being progressed by the Planning Policy Team.

Alyson Hutton (Manager Planning Policy) presented the item and highlighted key updates from the tables in the report attachments.

Ms Hutton responded to various questions about the dates and timeframes regarding some of the hearings.

Members sought clarification on whether the Te Tapuae Structure Plan (TTSP) workload could qualify for a Plan Stop exemption, and whether additional Environment Court appeals could be lodged at later stages of the planning process. Ms Hutton confirmed that the team is applying for an exemption for TTSP projects based on the need to respond to population growth. She also advised that while appeals must be lodged within a prescribed timeframe, further appeals may be possible at subsequent stages.

In discussion, Ms Hutton acknowledged the Urban Intensification Variation as a significant and necessary project, driven by the Spatial Plan and in response to Central Government directives. She noted the substantial volume of submissions for this variation.

It was also noted that the Planning Policy Team are continuing to seek clarification on Plan Stop legislation and implications on current and future projects.

It was moved (Councillor Wong/ Councillor Bruce):

That the Planning & Strategy Committee:

- 2. Note the updates on timing and progress on projects undertaken by the Planning Policy Team.
