### Context – Developing the LTP



- Constrained fiscal environment
- Accommodating three waters has meant a lot of community strategic priorities have been deferred
- Focus of first 2 years is mostly renewals
- Long Term Plan won't be confirmed until 19th September 2024 (however renewals are ongoing)

## Parks Years 1-3 Projects



#### Years 1-2

- Renewals and minor improvements
- Taking opportunities for small improvements where budget allows e.g. implementation of development plans
- Completion of Mount Iron RMP
- Ongoing management of Mount Iron e.g. community governance, vesting of DOC land
- Additional wildfire planning/prevention

### Year 3

- Mount Iron capital improvements
- Wildfire programme implementation
- Lake Hāwea playground
- New toilets

- Fence removed along SH84 at Mount Iron May 2024
- Luggate playground opening May 2024
- Perimeter fencing at the Wanaka Cemetery May 2024
- Gladstone track signage May 2024
- New track counter at Mount Iron May 2024

## Mount Iron Reserve Management Plan



- RMP being drafted
- Community Board workshop to review draft RMP policies on 28 May

- Public consultation Aug-Sept 2024



## Stage 5 Wānaka Lakefront Development



- Construction tender closed 20 May 2024
- Contract to be awarded June 2024
- Work completion anticipated prior to Summer 2024/25.






## 'Quick wins' for Stage 4 Wānaka Lakefront

## Tracks and Trails – Renewals program



The largest package of works ever delivered on the Upper Clutha trails network in a single year. In collaboration with the UCTT





Projects at both sites include:
Resurfacing
Culvert and water channels
Trail widening to 2.5m

Projects are included in wider package of works.
The contract has now been awarded and will be delivered in Q4
