- 1. I, Allister John Saville, wish to be a party to the following appeals:
  - (a) Arthur's Point Protection Society Incorporated ENV-2018-CHCH-000067 ("Arthur's Point Appeal").
  - (b) Andrew Fairfax and Ian and Philippa Macauley ENV-2018-CHCH-000096 ("Fairfax Appeal").
  - (c) Aircraft Owners and Pilots Association (NZ) Inc ENV-2018-CHCH-000132 ("Aircraft Owners' Appeal").

(together "Additional Appeals").

- 2. I am already a party to *Clive Manners Wood v Queenstown Lakes District Council* ENV-2018-WGN-00057 ("**Wood Appeal**").
- 3. I did not make a submission on the subject matter of each of Additional Appeals, but I am a person who has an interest in each of the proceedings that is greater than the interest that the general public has. This is because:
  - (a) Each of the Additional Appeals relates to the planning provisions and framework under the Proposed District Plan ("PDP") relating to "informal airports". Informal airports include helipads for private use.
  - (b) At the time the PDP was proposed, I did not think that I would be affected by informal airports or helipads. However, my immediate neighbour, Mr Roberts, has sought resource consent to operate a helipad on his property at 704 Malaghan Road. I am directly affected by that application.
  - (c) Mr Roberts seeks, in part, to justify his application and its effects by reference to the provisions of the PDP relating to informal airports.
  - (d) I expect that Mr Roberts' application will be publicly notified. Even if it is not, I should still be limited notified of it. It may therefore take some time for Mr Roberts' application to be resolved, and the outcome may be impacted by the progress of the Appeals.
  - (e) It is also possible, if not likely, that other applications for consent for helipads will be made in vicinity of my property, or more widely, with resulting cumulative effects including on the rural character and amenity. The resolution of the PDP provisions relating to these matters is therefore likely to affect me in the long term.
  - (f) Accordingly, I stand to be affected by and/or have an "interest" in the proceedings greater than the general public (who may not be directly affected by the resolution of the proceedings).
- 4. I am not a trade competitor for the purposes of section 108B of the Act.
- 5. I am interested in all of the proceedings.

- 6. My position in respect of the relief sought in each of the Additional Appeals is as follows:
  - (a) I support the relief sought in the Arthur's Point Appeal, for the reasons given in that Appeal and/or the Woods Appeal.
  - (b) I oppose the relief sought in the other Additional Appeals, as that relief is inconsistent with the relief sought and reasons given in the Arthur's Point Appeal and/or the Woods Appeal.
- 7. I agree to participate in mediation or other alternative dispute resolution processes.
