  - (a) Tussock Rise Limited v Queenstown Lakes District Council (ENV-2018-CHC-121) (Appeal).
- 2.   - (b) Alpine has an interest in ensuring that the nature of activities carried out along the boundary of Lot 2 DP 477622 and 8 Connell Terrace are compatible.
