- The NZ Transport Agency ('Transport Agency') wishes to be a party to an appeal by Alps Investment Limited ('AlL') against the decisions of the Queenstown Lakes District Council ('Council') on Stage 1 of the Proposed Queenstown Lakes District Plan ('Proposed Plan') (Court reference ENV-2018-CHC-149).
- 2 The Transport Agency:
 - a made a submission about the subject matter of the proceedings (submitter 719); and
